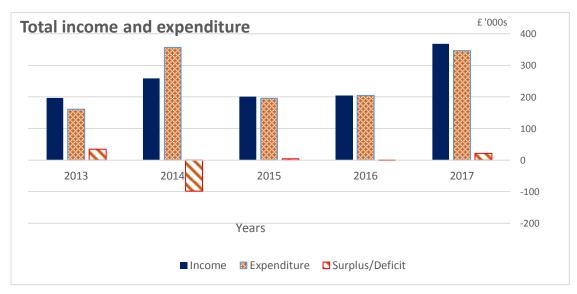
Introduction

The 2017 end year financial accounts (January to December) have been compiled using OPAS (the Diocese accounting system). Key financial points are provided below.

Financial Summary

The total assessable income received from the Parish has improved, however, the total expenditure costs have also increased mainly as result of the large project costs associated with the refurbishment of Manus Domini which now houses the Chemin Neuf Community and the discounted diocesan assessment has ceased. The graph below shows at the end of 2017, although the total income was higher than expenditure this includes a £50k loan from the Diocese.



The breakdown of the accounts for 2017 can be found on page 2 and the previous years' figures are provided to enable comparisons to be made with previous years.

2017 achievements worth noting are the:
