Annual Finance Report for 2019 from the Parish Finance Committee

Introduction

The financial returns for 2019 (January to December) have been compiled using OPAS (the Diocese bookkeeping entry system) and submitted to Westminster Diocese for approval. The Parish outlay during 2019 was approximately £60,000 more than the income received to incorporate the planned refurbishment expenditure of the ground floor of the church; refurbishment costs were met by legacies kindly gifted to the parish during 2018.

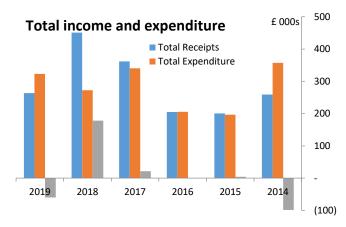
Financial Summary

The expenditure costs increased in 2019 mainly due to the refurbishment of the main entrance, the replating of chalices and the ongoing loan repayments (and associated interest fees). In addition, the Parish continues to support CAFOD by charging below the market rate rental (~£10k circa) for their office. The breakdown of the 2019 accounts is shown on page 2 along with previous years' to draw comparisons.

2019 achievements worth noting are the:

- •Number and value of standing orders remain steady
- Efforts to maximise tax refunds continues to be successful
- Hall hire revenue increased and steady additional income from rental of first floor flat
- Refurbishment of chairs and installation of stair lift (parishioner donations contributing to associated costs)
- Church entrance refurbished doors, lighting and flooring
- Kneelers purchased to match chair upholstery (parishioner donations)
- Outside drainage system replaced

- •Small hall redecorated by parishioners
- Purchase of music workstation
- •New external church signage



Next year's budget has been determined to include building projects to cover the refurbishment of the Confessional area, provide new heating controls, add new flooring for the ground floor corridors and for the large hall redecoration which has already been completed by our parishioners.

Legacies left to the parish have been greatly appreciated. These funds have made a lasting difference to the future of our church.
