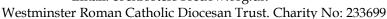

2020 Parish Finance Report

Introduction

The diocese has now received the parish's 2020 income and expenditure submission and we are awaiting their approval. The unprecedented challenge which the COVID-19 pandemic presented continues for our parish (as it does for everyone). The parish continues to adapt to meet the needs and services of the parishioners. The support and generosity of parishioners have been unwavering and together with legacies and specific donations, which have been greatly appreciated, these ensure a lasting effect for the future of our church.

Financial Summary

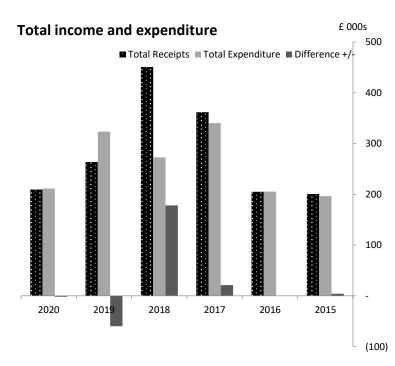
2020 income has materially reduced due to the closure of the church following government guidelines. In light of this, the finance committee took the sensible view to ensure only essential costs and repairs to the Church were carried out.

The Diocese implemented several actions to help address the reduced parish income including a loan repayment amnesty, which the Parish accepted for a short period, and access to the government furlough scheme, which we continue to receive. 2021 will continue to be a challenging year, and the finance committee will work to ensure both the budget and work programme are aligned to meet these challenges.

The breakdown of the accounts is shown on page 2 along with previous years to draw comparisons.

Despite these challenges our parish's notable achievements in 2020 include:

- Increasing the number of standing orders.
- Providing contactless giving methods for the convenience and safety of parishioners.
- Refurbishment of the large hall by parishioners.
- Specific donations to optimise online streaming arrangements for masses and other services.
- New heating controls, due to the obsolescence of existing ones, provide improved efficiencies.
- Continued efforts to maximise tax refunds
- Expanding and improving the broadband facility to support the delivery of Live Streaming and the pastoral programme.
