2021 Parish Finance Report

Introduction

The Finance committee have submitted the parish's 2021 income and expenditure figures and are awaiting their approval. The challenges from the COVID-19 pandemic for both the parish and society continue and are being actively managed to ensure the needs and services of the parishioners are met. The generosity and support from our parishioners remain steadfast, enabling the parish to maintain and improve our church.

Financial Summary

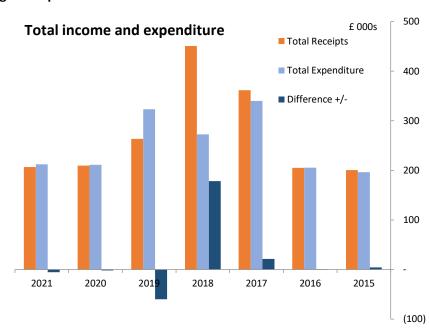
Income was broadly in line with the previous year figures as again the closure of the church in the early part of the 2021 occurred following government guidelines. Similar to 2020, the finance committee continued to ensure only essential costs and repairs to the Church were carried out.

The Diocese rolled over to 2021 several options available to help parishes address the reduced income, for example access to the government furlough scheme and the insurance holiday period which our parish accepted. The finance committee remains committed to ensure both the budget and work programme are aligned to the parish resources.

The breakdown of the accounts is shown on page 2 along with previous years to draw comparisons.

Despite the ongoing challenges our parish's notable achievements in 2021 include:

- Increased revenue from the use of the first floor flat and rental space of rooms and halls;
- Phase 1 installation of the replacement fire doors to improve security to the premises;
- Increased donations via use of onsite card reader machine;
- Youth Cabin repairs
- Purchase of garden equipment; and
- CCTV upgrade
